Exhibits, Digital Media, Programs & Partnerships: To advance its mission of igniting our community's passion for nature and science, the Denver Museum of Nature & Science presents a dynamic menu of permanent and temporary exhibits (Stonehenge, Numbers in Nature, Sue: A T.rex Experience, Art of the Brick, Dogs! A Science Tail), engaging programming, educational films in its IMAX theater, and awe inspiring shows in its digital Planetarium. Diverse program offerings for children, adults, families and teens include exciting science theater shows and facilitations, lectures, documentary film screenings, school break camps, and family activity programs. ExciteEd programs for schools include rigorous teacher professional development classes and school group Field Trip Adventures (classes), (SEE SCHEDULE O)

4b (Code:) (Expenses \$ 4,448,740. including grants of \$ 37,650.) (Revenue \$) Science Division: Museum researchers contribute to scientific knowledge through collection and analysis of data, which are then used to generate and publish new understandings about the earth, its inhabitants, and beyond. The Science staff manages, preserves, and provides access to the Museum's collection of 4.3 million objects and specimens. During 2020, staff fielded 425 research requests from collaborators inside and outside the museum. The Science Division also engages in abundant educational outreach, communicating science to 113,742 members of the general public and its research community through courses, events, tours, lectures, and fieldtrips in 2020 alone. 2,868 of these guests attended collection open houses or behind the scenes tours of the Avenir Collections Center. (SEE SCHEDULE O)

a large core of volunteers eager to return in late 2021, and we have

times. Research highlights from the year include the discovery of a new

exhibit and was the subject of a multi-chapter monograph in the *Society
of Vertebrate Paleontology Memoir series*. In addition, the NIH SEPA
